GENERAL POWER TOOL SAFETY WARNINGS



WARNING: Read all safety warnings, instructions, illustrations and specifications provided with this power tool. Failure to follow all instructions listed below may result in electric shock, fire and/or serious injury.

SAVE ALL WARNINGS AND INSTRUCTIONS FOR FUTURE REFERENCE.

The term "power tool" in the warnings refers to your mainsoperated (corded) power tool or battery-operated (cordless) power tool.

1) Work Area Safety

- a) **Keep work area clean and well lit.** Cluttered or dark areas invite accidents.
- b) Do not operate power tools in explosive atmospheres, such as in the presence of flammable liquids, gases or dust. Power tools create sparks which may ignite the dust or fumes.
- c) Keep children and bystanders away while operating a power tool. Distractions can cause you to lose control.

2) Electrical Safety

- a) Power tool plugs must match the outlet. Never modify the plug in any way. Do not use any adapter plugs with earthed (grounded) power tools.
 Unmodified plugs and matching outlets will reduce risk of electric shock.
- b) Avoid body contact with earthed or grounded surfaces such as pipes, radiators, ranges and refrigerators. There is an increased risk of electric shock if your body is earthed or grounded.
- Do not expose power tools to rain or wet conditions.
 Water entering a power tool will increase the risk of electric shock.
- d) Do not abuse the cord. Never use the cord for carrying, pulling or unplugging the power tool. Keep cord away from heat, oil, sharp edges or moving parts. Damaged or entangled cords increase the risk of electric shock.
- e) When operating a power tool outdoors, use an extension cord suitable for outdoor use. Use of a cord suitable for outdoor use reduces the risk of electric shock.
- f) If operating a power tool in a damp location is unavoidable, use a residual current device (RCD) protected supply. Use of an RCD reduces the risk of electric shock.

3) Personal Safety

a) Stay alert, watch what you are doing and use common sense when operating a power tool. Do not use a power tool while you are tired or under the influence of drugs, alcohol or medication. A moment

- of inattention while operating power tools may result in serious personal injury.
- b) Use personal protective equipment. Always wear eye protection. Protective equipment such as a dust mask, non-skid safety shoes, hard hat or hearing protection used for appropriate conditions will reduce personal injuries.
- c) Prevent unintentional starting. Ensure the switch is in the off-position before connecting to power source and/or battery pack, picking up or carrying the tool. Carrying power tools with your finger on the switch or energising power tools that have the switch on invites accidents.
- d) Remove any adjusting key or wrench before turning the power tool on. A wrench or a key left attached to a rotating part of the power tool may result in personal injury.
- e) Do not overreach. Keep proper footing and balance at all times. This enables better control of the power tool in unexpected situations.
- f) Dress properly. Do not wear loose clothing or jewellery. Keep your hair and clothing away from moving parts. Loose clothes, jewellery or long hair can be caught in moving parts.
- g) If devices are provided for the connection of dust extraction and collection facilities, ensure these are connected and properly used. Use of dust collection can reduce dust-related hazards.
- h) Do not let familiarity gained from frequent use of tools allow you to become complacent and ignore tool safety principles. A careless action can cause severe injury within a fraction of a second.

4) Power Tool Use and Care

- a) Do not force the power tool. Use the correct power tool for your application. The correct power tool will do the job better and safer at the rate for which it was designed.
- b) **Do not use the power tool if the switch does not turn it on and off.** Any power tool that cannot be controlled
 with the switch is dangerous and must be repaired.
- c) Disconnect the plug from the power source and/ or remove the battery pack, if detachable, from the power tool before making any adjustments, changing accessories, or storing power tools. Such preventive safety measures reduce the risk of starting the power tool accidentally.
- d) Store idle power tools out of the reach of children and do not allow persons unfamiliar with the power tool or these instructions to operate the power tool. Power tools are dangerous in the hands of untrained users.
- e) Maintain power tools and accessories. Check for misalignment or binding of moving parts, breakage of parts and any other condition that may affect the power tool's operation. If damaged, have the power tool repaired before use. Many accidents are caused by poorly maintained power tools.

- f) **Keep cutting tools sharp and clean.** Properly maintained cutting tools with sharp cutting edges are less likely to bind and are easier to control.
- g) Use the power tool, accessories and tool bits, etc. in accordance with these instructions, taking into account the working conditions and the work to be performed. Use of the power tool for operations different from those intended could result in a hazardous situation.
- h) Keep handles and grasping surfaces dry, clean and free from oil and grease. Slippery handles and grasping surfaces do not allow for safe handling and control of the tool in unexpected situations.

5) Battery Tool Use and Care

- a) Recharge only with the charger specified by the manufacturer. A charger that is suitable for one type of battery pack may create a risk of fire when used with another battery pack.
- b) Use power tools only with specifically designated battery packs. Use of any other battery packs may create a risk of injury and fire.
- c) When battery pack is not in use, keep it away from other metal objects, like paper clips, coins, keys, nails, screws or other small metal objects, that can make a connection from one terminal to another. Shorting the battery terminals together may cause burns or a fire.
- d) Under abusive conditions, liquid may be ejected from the battery; avoid contact. If contact accidentally occurs, flush with water. If liquid contacts eyes, additionally seek medical help. Liquid ejected from the battery may cause irritation or burns.
- Do not use a battery pack or tool that is damaged or modified. Damaged or modified batteries may exhibit unpredictable behaviour resulting in fire, explosion or risk of injury.
- f) Do not expose a battery pack or tool to fire or excessive temperature. Exposure to fire or temperature above 130 °C may cause explosion.
- g) Follow all charging instructions and do not charge the battery pack or tool outside the temperature range specified in the instructions. Charging improperly or at temperatures outside the specified range may damage the battery and increase the risk of fire.

6) Service

- a) Have your power tool serviced by a qualified repair person using only identical replacement parts. This will ensure that the safety of the power tool is maintained.
- b) Never service damaged battery packs. Service
 of battery packs should only be performed by the
 manufacturer or authorized service providers.

Additional Safety Rules for Expansion Tools



WARNING: Use the expander tool only with DEWALT or DEWALT-approved attachments. Other uses or modifying the expander tool for other applications may damage the expander tool, damage the attachments and/or can result in a faulty installation. Faulty installations can result in catastrophic failures, injury to installers and damage to property.



WARNING: Proper preparation and installation is the responsibility of the installing contractor.

- Keep all body parts away from the attachments during operation and any time the power is ON. A moment of inattention while operating power tools may result in serious personal injury. Fingers or hands can be pinched if they become caught in the attachments.
- Inspect tool and attachments before use. Never attempt to repair or use a damaged expander head or other attachment. Replace with a new expander head.
- This tool produces large forces that can break attachments or parts and cause injury. Always be attentive and take proper safety precautions, including wearing eye protection.
- Only trained personnel should operate this tool.
- Before operating, inspect job site for hazards including chemicals or waste that could remain in pipes.
- Before operating, read and understand all safety and operating instructions including the fitting manufacturer's installation instructions and the instructions for any other equipment used with this tool.
 Failure to follow all instructions and warnings may result in property damage and/or serious personal injury.
- Secure and support the material to prevent movement during operation.
- Keep a firm grip on the tool at all times. Forces on the tool may change during and after the operation.
- Expansion operations may cause material pieces to fly. Flying particles can cause permanent eye damage.
 ALWAYS wear eye protection.
- Always wear gloves when operating tool and handling materials. The ends of the materials can be sharp and can cause serious personal injury.
- Always wear safety shoes to protect your feet from sharp metal debris on the floor.
- To reduce the chance of damage to your PEX expander, always store your tool with the expander head installed.
- The expander cone's sharp end may cause injury to the user without the expander head installed.
- Improper lubrication may lead to defective connections.

Residual Risks

In spite of the application of the relevant safety regulations and the implementation of safety devices, certain residual risks cannot be avoided. These are:

Risk of personal injury due to flying particles.

SAVE THESE INSTRUCTIONS

Chargers

DEWALT chargers require no adjustment and are designed to be as easy as possible to operate.

Electrical Safety

Make sure that the voltage of your charger corresponds to that of your mains.



Your DEWALT charger is double insulated, therefore no earth wire is required.

If the supply cord is damaged, it must be replaced only by DEWALT or an authorised service organisation.

Using an Extension Cable

An extension cord should not be used unless absolutely necessary. Use an approved extension cable suitable for the power input of your charger (see *Technical Data*). The minimum conductor size is 1 mm²; the maximum length is 30 m.

When using a cable reel, always unwind the cable completely.

Important Safety Instructions for All Battery Chargers



WARNING: Observe all safety instructions on chargers and batteries.



WARNING: Shock hazard. Do not allow any liquid to get inside charger. Electric shock may result.



WARNING: We recommend the use of a residual current device with a residual current rating of 30mA or less.



CAUTION: Burn hazard. To reduce the risk of injury, charge only DEWALT rechargeable batteries. Other types of batteries may burst causing personal injury and damage.



CAUTION: Children should be supervised to ensure that they do not play with the appliance.

NOTICE: Under certain conditions, with the charger plugged into the power supply, the exposed charging contacts inside the charger can be shorted by foreign material. Foreign materials of a conductive nature such as, but not limited to, steel wool, aluminum foil or any buildup of metallic particles should be kept away from charger cavities. Always unplug the charger from the power supply when there is no battery pack in the cavity. Unplug charger before attempting to clean

- DO NOT attempt to charge the battery pack with any chargers other than the ones in this manual. The charger and battery pack are specifically designed to work together (refer to the battery/charger table in this manual).
- These chargers are not intended for any uses other than charging DEWALT rechargeable batteries. Any other uses may result in risk of fire, electric shock or electrocution.
- **Do not expose charger to rain or snow.** Water entering a power tool will increase the risk of electric shock.
- Pull by plug rather than cord when disconnecting charger. This will reduce risk of damage to electric plug and cord.
- Make sure that cord is located so that it will not be stepped on, tripped over, or otherwise subjected to damage or stress.

- Do not use an extension cord unless it is absolutely necessary. Use of improper extension cord could result in risk of fire, electric shock, or electrocution.
- Do not place any object on top of charger or place the charger on a soft surface that might block the ventilation slots and result in excessive internal heat. Place the charger in a position away from any heat source. The charger is ventilated through slots in the top and the bottom of the housina.
- Do not operate charger with damaged cord or plug have them replaced immediately.
- Do not operate charger if it has received a sharp blow, been dropped, or otherwise damaged in any way. Take it to an authorised service centre.
- Do not disassemble charger; take it to an authorised service centre when service or repair is required. Incorrect reassembly may result in a risk of electric shock, electrocution or fire.
- Disconnect the charger from the outlet before attempting any cleaning. This will reduce the risk of electric shock. Removing the battery pack will not reduce this risk.
- NEVER attempt to connect two chargers together.
- The charger is designed to operate on standard 220-240V household electrical power. Do not attempt to use it on any other voltage. This does not apply to the vehicular charger.

Charging a Battery (Fig. B)


NOTE: To ensure maximum performance and life of lithium-ion battery packs, charge the battery pack fully before first use.

- 1. Plug the charger into an appropriate outlet before inserting battery pack.
- Insert the battery pack into the charger, making sure the battery pack is fully seated in the charger. The red (charging) light will blink repeatedly indicating that the charging process has started.
- 3. The Stage 1 Charging blink indicator represents the charge process that charges the majority of the battery's capacity. Stage 2 Charging blink indicator represents the remainder, or top off charge process, for the battery to reach full capacity.
- 4. The completion of charge for Stage 1 or Stage 2 will be indicated by the Stage's light remaining ON continuously. The battery pack is fully charged when both Stage 1 and Stage 2 Charging lights remain ON continuously, and it may be removed and used at this time or left in the charger.

NOTE: To remove the battery pack, some chargers require the battery pack release button to be pressed.

Charger Operation

Refer to the indicators below for the charge status of the battery pack.



*The red light will continue to blink, but a yellow indicator light will be illuminated during this operation. Once the battery pack has reached an appropriate temperature, the yellow light will turn off and the charger will resume the charging procedure.

The compatible charger(s) will not charge a faulty battery pack. The charger will indicate faulty battery by refusing to light.

NOTE: This could also mean a problem with a charger. If the charger indicates a problem, take the charger and battery pack to be tested at an authorised service centre.

Hot/Cold Pack Delay

When the charger detects a battery pack that is too hot or too cold, it automatically starts a Hot/Cold Pack Delay, suspending charging until the battery pack has reached an appropriate temperature. The charger then automatically switches to the pack charging mode. This feature ensures maximum battery pack life.

A cold battery pack will charge at a slower rate than a warm battery pack. The battery pack will charge at that slower rate throughout the entire charging cycle and will not return to maximum charge rate even if the battery pack warms.

The DCB118 charger is equipped with an internal fan designed to cool the battery pack. The fan will turn on automatically when the battery pack needs to be cooled. Never operate the charger if the fan does not operate properly or if ventilation slots are blocked. Do not permit foreign objects to enter the interior of the charger.

Electronic Protection System

XR Li-lon tools are designed with an Electronic Protection System that will protect the battery pack against overloading, overheating or deep discharge.

The tool will automatically turn off if the Electronic Protection System engages. If this occurs, place the lithium-ion battery pack on the charger until it is fully charged.

Wall Mounting

These chargers are designed to be wall mountable or to sit upright on a table or work surface. If wall mounting, locate the charger within reach of an electrical outlet, and away from a corner or other obstructions which may impede air flow. Use the back of the charger as a template for the location of the mounting screws on the wall. Mount the charger securely using drywall screws (purchased separately) at least 25.4 mm long with a screw head diameter of 7–9 mm, screwed into wood to an optimal depth leaving approximately 5.5 mm of the screw

exposed. Align the slots on the back of the charger with the exposed screws and fully engage them in the slots.

Charger Cleaning Instructions



WARNING: Shock hazard. Disconnect the charger from the AC outlet before cleaning. Dirt and grease may be removed from the exterior of the charger using a cloth or soft non-metallic brush. Do not use water or any cleaning solutions. Never let any liquid get inside the tool; never immerse any part of the tool into a liquid.

Battery Packs

Important Safety Instructions for All Battery Packs



WARNING: DEWALT batteries should only be used with DEWALT products.

When ordering replacement battery packs, be sure to include catalogue number and voltage.

The battery pack is not fully charged out of the carton. Before using the battery pack and charger, read the safety instructions below. Then follow charging procedures outlined.

READ ALL INSTRUCTIONS

- Do not charge or use battery in explosive atmospheres, such as in the presence of flammable liquids, gases or dust. Inserting or removing the battery from the charger may ignite the dust or fumes.
- Never force battery pack into charger. Do not modify battery pack in any way to fit into a non-compatible charger as battery pack may rupture causing serious personal injury.
- Charge the DEWALT battery packs only in DEWALT chargers.
- **DO NOT** splash or immerse in water or other liquids.
- Do not store or use the tool and battery pack in locations where the temperature may fall below 4°C (34°F) (such as outside sheds or metal buildings in winter), or reach or exceed 40°C (104°F) (such as outside sheds or metal buildings in summer).
- **Do not incinerate the battery pack even if it is severely damaged or is completely worn out.** The battery pack can explode in a fire. Toxic fumes and materials are created when lithium-ion battery packs are burned.
- If battery contents come into contact with the skin, immediately wash area with mild soap and water. If battery liquid gets into the eye, rinse water over the open eye for 15 minutes or until irritation ceases. If medical attention is needed, the battery electrolyte is composed of a mixture of liquid organic carbonates and lithium salts.
- Contents of opened battery cells may cause respiratory irritation. Provide fresh air. If symptoms persists, seek medical attention.



WARNING: Burn hazard. Battery liquid may be flammable if exposed to spark or flame.



WARNING: Never attempt to open the battery pack for any reason. If battery pack case is cracked or damaged, do not insert into charger. Do not crush, drop or damage

battery pack. Do not use a battery pack or charger that has received a sharp blow, been dropped, run over or damaged in any way (i.e., pierced with a nail, hit with a hammer, stepped on). Electric shock or electrocution may result. Damaged battery packs should be returned to service centre for recycling.



WARNING: Fire hazard. Do not store or carry the battery pack so that metal objects can contact exposed battery terminals. For example, do not place the battery pack in aprons, pockets, tool boxes, product kit boxes, drawers, etc., with loose nails, screws, keys, etc.



CAUTION: When not in use, place tool on its side on a stable surface where it will not cause a tripping or falling hazard. Some tools with large battery packs will stand upright on the battery pack but may be easily knocked over.

Transportation



WARNING: Fire hazard. Transporting batteries can possibly cause fire if the battery terminals inadvertently come in contact with conductive materials. When transporting batteries, make sure that the battery terminals are protected and well insulated from materials that could contact them and cause a short circuit. **NOTE:** Lithium-ion batteries should not be put in checked baggage.

DEWALT batteries comply with all applicable shipping regulations as prescribed by industry and legal standards which include UN Recommendations on the Transport of Dangerous Goods; International Air Transport Association (IATA) Dangerous Goods Regulations, International Maritime Dangerous Goods (IMDG) Regulations, and the European Agreement Concerning The International Carriage of Dangerous Goods by Road (ADR). Lithium-ion cells and batteries have been tested to section 38.3 of the UN Recommendations on the Transport of Dangerous Goods Manual of Tests and Criteria.

In most instances, shipping a DEWALT battery pack will be excepted from being classified as a fully regulated Class 9 Hazardous Material. In general, only shipments containing a lithium-ion battery with an energy rating greater than 100 Watt Hours (Wh) will require being shipped as fully regulated Class 9. All lithium-ion batteries have the Watt Hour rating marked on the pack. Furthermore, due to regulation complexities, DEWALT does not recommend air shipping lithium-ion battery packs alone regardless of Watt Hour rating. Shipments of tools with batteries (combo kits) can be air shipped as excepted if the Watt Hour rating of the battery pack is no greater than 100 Whr. Regardless of whether a shipment is considered excepted or fully regulated, it is the shipper's responsibility to consult the latest regulations for packaging, labeling/marking and documentation requirements.

The information provided in this section of the manual is provided in good faith and believed to be accurate at the time the document was created. However, no warranty, expressed or implied, is given. It is the buyer's responsibility to ensure that its activities comply with the applicable regulations.

Transporting the FLEXVOLT™ Battery

The DEWALT FLEXVOLT® battery has two modes: **Use** and **Transport**.

Use Mode: When the FLEXVOLT[™] battery stands alone or is in a DEWALT 18V (20V Max) product, it will operate as an 18V (20V Max)battery. When the FLEXVOLT[™] battery is in a 54V (60V Max) or a 108V (120V Max)(two 54V (60V Max) batteries) product, it will operate as a 54V (60V Max)battery.

Transport Mode: When the cap is attached to the FLEXVOLTTM battery, the battery is in Transport mode. Keep the cap for shipping.

When in Transport mode, strings of cells are electrically disconnected within the pack resulting in 3 batteries with a



lower Watt hour (Wh) rating as compared to 1 battery with a higher Watt hour rating. This increased quantity of 3 batteries with the lower Watt hour rating can exempt the pack from certain shipping regulations that are imposed upon the higher Watt hour batteries.

For example, the Transport Wh rating might indicate 3 x 36 Wh, meaning 3 batteries of 36 Wh each. The Use Wh rating might

indicate 108 Wh (1 battery implied).

Storage Recommendations

- The best storage place is one that is cool and dry away from direct sunlight and excess heat or cold. For optimum battery performance and life, store battery packs at room temperature when not in use.
- For long storage, it is recommended to store a fully charged battery pack in a cool, dry place out of the charger for optimal results.

NOTE: Battery packs should not be stored completely depleted of charge. The battery pack will need to be recharged before use.

Labels on Charger and Battery Pack

In addition to the pictographs used in this manual, the labels on the charger and the battery pack may show the following pictographs:



Read instruction manual before use.



See **Technical Data** for charging time.



Do not probe with conductive objects.



Do not charge damaged battery packs.



Do not expose to water.



Have defective cords replaced immediately.



Charge only between 4 °C and 40 °C.



Only for indoor use.



Discard the battery pack with due care for the environment.



Charge DEWALT battery packs only with designated DEWALT chargers. Charging battery packs other than the designated DEWALT batteries with a DEWALT charger may make them burst or lead to other dangerous situations.



Do not incinerate the battery pack.



USE (without transport cap). Example: Wh rating indicates 108 Wh (1 battery with 108 Wh).



TRANSPORT (with built-in transport cap). Example: Wh rating indicates 3 x 36 Wh (3 batteries of 36 Wh).

ASSEMBLY AND ADJUSTMENTS



WARNING: To reduce the risk of serious personal injury, turn tool off and disconnect battery pack before making any adjustments or removing/

installing attachments or accessories. An accidental start-up can cause injury.

Inserting and Removing the Battery Pack from the Tool (Fig. B)

NOTE: Make sure your battery pack 8 is fully charged.

To Install the Battery Pack into the Tool Handle

- 1. Align the battery pack **8** with the rails inside the tool's handle.
- 2. Slide it into the handle until the battery pack is firmly seated in the tool and ensure that you hear the lock snap into place.

To Remove the Battery Pack from the Tool

- 1. Press the battery pack release button **9** and firmly pull the battery pack out of the tool handle.
- 2. Insert battery pack into the charger as described in the charger section of this manual.

Fuel Gauge Battery Packs (Fig. B)

Some DEWALT battery packs include a fuel gauge which consists of three green LED lights that indicate the level of charge remaining in the battery pack.

To actuate the fuel gauge, press and hold the fuel gauge button. A combination of the three green LED lights will illuminate designating the level of charge left. When the level of charge in the battery is below the usable limit, the fuel gauge will not illuminate and the battery will need to be recharged.

NOTE: The fuel gauge is only an indication of the charge left on the battery pack. It does not indicate tool functionality and is subject to variation based on product components, temperature and end-user application.

Installing and Removing the Expander Head (Fig. A, C)

IMPORTANT: To reduce the chance of damage to your PEX expander, always store your tool with the expander head **2** installed.

- To install an expander head 2 screw onto the tool clockwise until hand tight. DO NOT over tighten.
- 2. To uninstall an expander head, unscrew from the tool counterclockwise.

Hang Hook (Fig. A, D)



WARNING: To reduce the risk of serious personal injury, ONLY use the tool's hang hook to hang the tool from a work belt. DO NOT use the hang hook for tethering or securing the tool to a person or object during use. DO NOT suspend tool overhead or suspend objects from the hang hook.



WARNING: To reduce the risk of serious personal injury, ensure the screws holding the hang hook are secure.



CAUTION: To reduce the risk of personal injury or damage, DO NOT use the hang hook to hang the expander tool while using as a spotlight.

IMPORTANT: When attaching or replacing the hang hook **1**, use only the screws **12** that are provided. Be sure to securely tighten the screws **12**.

The hang hook 7 can be be attached to either side of the tool using only the screws 12 provided, to accommodate left- or right- handed users.

NOTE: If the hang hook is not desired at all, it can be removed from the tool.

- To move the hang hook 7, remove the screws 12 that hold the hang hook 7 in place. Install removed screws and securely tighten the screws 12.
- Remove the screws 12 on the desired side of the tool and reassemble the hang hook 7. Be sure to securely tighten the screws.

OPERATION

Instructions for Use



WARNING: Always observe the safety instructions and applicable regulations.



WARNING: To reduce the risk of serious personal injury, turn tool off and disconnect battery pack before making any adjustments or removing/installing attachments or accessories. An accidental start-up can cause injury.



WARNING: Proper material preparation and installation is the responsibility of the installing contractor.



WARNING: The tubing and hardware must be used in compliance with applicable building codes and as approved by the authorities having jurisdiction.

For proper installation procedures and to reduce the risk of failure resulting in injury or property damage, follow all published safety and installation instructions and specifications of the Pex tubing.



CAUTION: Pinch hazard. Keep fingers away from expander head while in use.

Proper Hand Position (Fig. A, E)



WARNING: To reduce the risk of serious personal injury, **ALWAYS** use proper hand position as shown.



WARNING: To reduce the risk of serious personal injury, **ALWAYS** hold securely in anticipation of a sudden reaction.

Proper hand position requires one hand on the main handle 3.

Trigger Switch and Lock Off (Fig. A)

To turn the tool on, squeeze the trigger switch 4. To turn the tool off, release the trigger switch.

Your PEX expander is equipped with a trigger lock 5. To lock the trigger switch in the OFF postition, push the trigger lock from the left side of the tool. To unlock the trigger switch, push the trigger lock from the right side of the tool.

NOTE: Depressing the trigger switch will activate the LED worklight **6**. The LED worklight will automatically turn off after twenty seconds. To turn the light off immediately, remove and

reinstall the battery. The worklight is for lighting the immediate work surface and is not intended to be used as a flashlight.

NOTICE: To reduce the chance of damage to the tool **ALWAYS** lock the tool when not in use.

Creating a PEX Tubing Connection (Fig. A, F, G)



WARNING: Prior to use inspect all workpieces for cracks, defects or wear. Defective workpieces may shatter.



CAUTION: Using incorrectly sized expansion heads may result in a faulty connection, possibly resulting in damage to property.

To create a proper PEX tubing connection:

- 1. Select appropriate expander head 2 to match the tubing and, if needed, remove any dirt and debris.
- 2. Using a clean, lint-free cloth, apply a thin coat of DEWALT grease 10 to the expander cone 1. DO NOT over-lubricate.
- 3. Make a perpendicular cut to PEX tubing to the needed length. Use **ONLY** cutters designed for PEX tubing.
- 4. Slide the PEX ring 14 over the end of the PEX tubing 13 until it sits properly against the ring stop. If the PEX ring does not have a stop, leave an overhang of no more than 1.6 mm (Fig. G).
- 5. Insert the expander head into the PEX tubing (Fig. F).
- 6. Squeeze the trigger switch 4. The expander head will begin to expand, retract, and rotate slightly.

NOTE: Hold the ring and tubing so they do not rotate with the head.

Do not expand more times than necessary.

NOTE: The number of expansions needed may vary depending on temperature or user technique. To avoid over-expanding the PEX tubing, do not keep tool in the expanded position with PEX tubing in place.

- After achieving the recommended number of expansions, remove the tubing when the expander cone 1) segments are retracted and release the trigger switch 4. DO NOT expand the PEX tubing beyond the tool's capacity of 40 mm (up to 3.7 mm wall thickness).
- 8. Wipe off the excess grease from inside the PEX tubing.
- 9. Slide the PEX tubing over the fitting until it is flush with the fitting shoulder. The connection may be tight. If you are unable to slide the PEX tubing over the fitting, remove the fitting from the PEX tubing and re-expand until you can secure a proper fit.

NOTE: The PEX tubing should fit tightly against the fitting shoulder. If there is more than a 1.6 mm gap between the PEX tubing and the shoulder. If there is a gap larger than 1.6 mm:

- For 25 mm and below tubing, cut 50 mm off the end of the PEX tubing and restart the procedure with a new PEX Ring.
- For 25 mm above, cut 70 mm off the end of the PEX tubing and restart the procedure with a new PEX Ring.

Cold Weather Use

Use of your PEX expander in colder temperatures (4 °C) requires a longer contraction time and less expansions. Attempting to make PEX connections in extreme temperatures (-15 °C) is not recommended

Expansion Markings (Fig. H)



CAUTION: Incorrect expansion of the PEX tubing can create deep grooves in the material which could result in faulty connections and risk of property damage.

Examples of correct and incorrect markings on the inside of the PEX tubing are shown in Fig. H. Incorrect markings could indicate the head is not rotating properly, or the tubing is rotating with the head.

MAINTENANCE

Your DEWALT power tool has been designed to operate over a long period of time with a minimum of maintenance. Continuous satisfactory operation depends upon proper tool care and regular cleaning.



WARNING: To reduce the risk of serious personal injury, turn tool off and disconnect battery pack before making any adjustments or removing/installing attachments or accessories. An accidental start-up can cause injury.

The charger and battery pack are not serviceable.

Lubrication

To lubricate the head use only DEWALT PEX Expander Grease.

Cleaning



WARNING: Blow dirt and dust out of the main housing with dry air as often as dirt is seen collecting in and around the air vents. Wear approved eye protection and approved dust mask when performing this procedure.



WARNING: Never use solvents or other harsh chemicals for cleaning the non-metallic parts of the tool. These chemicals may weaken the materials used in these parts. Use a cloth dampened only with water and mild soap. Never let any liquid get inside the tool; never immerse any part of the tool into a liquid.

Cleaning the Expander Head and Cone (Fig. A)

- 1. Remove the expander head 2 and soak in a degreasing agent to remove grease from between expander segments.
- 2. Wipe expander cone 1 with clean, dry, lint-free cloth.
- 3. Re-lubricate using DEWALT grease.


